Zone 6 –

DG Jane/Lions:

What a year this has been so far!! Who would have anticipated back in January where we would be today with the "New Normal" both in our personal lives and our Lions family? But we Lions are adaptable, and the Lions of Zone 6 exemplify this!!

After shutting down for over four months our clubs are slowly starting to reemerge. The priority however is to ensure the health and safety of our Lions members as our clubs slowly begin to resume operations and that of the community we serve. Like all clubs, evolving provincial pandemic protocols will pose challenges moving forward in all that we do.

All our clubs have resumed club meetings in one form or another. This is good news as we can socialize with our fellow Lions and start planning on how to serve our communities again. All our clubs have applied for the NS reopening grant and some have applied for the County of Kings Grants. Some clubs have received funding while others are waiting for approval. This is great news for the clubs and provides much needed assistance.

From July through August I was able to meet individually with each of the Clubs in the zone, touching base with them to introduce myself as the new Zone Chair, to listen to them to see how they were dealing with the COVID-19 imposed restrictions and provide advice and information. I was impressed with the ways every one of the clubs adapted to their particular circumstances in order to weather the shutdown.

On September 22nd I chaired my first Zone 6 meeting, attended only by the club Presidents, Vice-presidents, and Secretaries. This format was well received by them and it was energizing to see the discussions, sharing of ideas, concerns and challenges that took place. The spirit of sharing and collaboration is alive and well in Zone 6!!

Challenges facing our clubs include:

- Demographically, a large percentage of our members are more susceptible to the worst effects of COVID-19.
- Overcoming social isolation of our members,
- · Retention and engagement of members,
- Fiscal restraints and hardships given lack of fundraising or another lockdown due to a second wave, and
- Reinforcing to the community that as we emerge, our events and halls are safe, by following all pandemic protocols which will increase participation.

However, as pandemic restrictions have eased, I am happy to report that we have begun to resume some normalcy in our activities.

In **Kentville**, they have emerged and have resumed their Friday weekly downtown BBQs, keeping the club in the public eye on a regular basis. They moved their Wednesday night Jam Session outdoors to Centre Square. Public support has been inspiring with, on average, over 55 people attending this weekly free-will offering event, purchasing 50/50 tickets, and partaking of sausages & hotdogs. Monthly breakfasts have resumed as well.

Berwick has continued to host vital Blood Donor Clinics and have begun renting out their hall once again. They held their first meeting on Sept 3rd and on Sept 22nd, they held a tremendously successful takeout Chicken BBQ. The support of the community was overwhelming with 375 meals being served. Not bad when they were only anticipating 200 originally!!

The honking of car horns indicating a Bingo!! and movie snacks are back in **Coldbrook**! They restarted weekly Drive-in movies and Bingos. They continue to support Camp Lion Maxwell, local schools, and the Valley Regional Hospital. Supporting the everyday needs of their community they have purchased eyeglasses, helped seniors with bill payments and medical needs. To include everyone in their club meetings, including those who want to participate from home, they will be using Zoom to include them. Lion Kirk encourages all clubs to learn and use technology to help their clubs stay connected.

Solar Power is the key word in **Kingston**. The club installed a solar power system that will generate up to 2/3 of their yearly power needs, paying for itself over the next 10 years and freeing up more funds to support the community! They delivered 178 complimentary cold plate suppers to staff at Soldiers Memorial Hospital and EMS in

Middleton, thanking them for their front-line support. They developed a comprehensive Business Re-opening plan, resumed take-out and delivery community luncheons, and assisted in the deliver of groceries to those who could not go out to get groceries.

The **Aylesford** club has started meeting again and on September 16th, they inducted two new members in the Club and conducted installation of Club Officers. The Hall is used by Scouts and TOPS free if charge and was recently donated to host a fundraiser dinner for a cancer victim. Hall rental has also resumed with the funds raised going toward upkeep and improvements to their hall. They use their LED sign to advertise community events and services.

Because of the shutdown, the clubs were forced to significantly reduce their service activities and become frugal. A "second wave" is on everyone minds however all clubs and members must work at keeping in touch with one another, help each other out and continue to share best practices moving forward.

Zone Six remains strong and committed to supporting each other and our communities moving forward in this pandemic environment. Remember, stay safe, physically distance, wear a mask and wash your hands!!

As communication seems to be an issue among clubs in the Zone, District, & Multiple, I decided a bulletin would be a good start for our Zone to ensure information reaches all Lions.

Zone 11 now has a monthly bulletin. This is designed to highlight what each club is doing (to give ideas to other clubs in the Zone); what the District is doing – Cabinet meetings, GMT, GLT, GST, projects etc...; also some facts about the Multiple District.

District N2 Fall Cabinet GST Coordinator Report Saturday, October 3, 2020

District Governor Jane, 1st VDG David, 2nd VDG Bill, PCC Peter, Fellow Lions.

Clearly, the covid 19 virus is having a noticeable impact on clubs being able to provide service activities in their communities. Looking at the metrics on MyLion as of October 1st with only 20 clubs reporting our District has completed 225 service projects, served 14,264 people, and volunteered 3162 hours. Of the 225 service projects 4 were related to the environment, 10 to hunger, 10 to vision and 201 were other types of activities. Clubs have raised \$26,064 USD and so far donated \$14,502 USD.

On August 31st the Global Service Team sent a survey to all the club presidents and secretaries regarding the following questions: Does your club have a CSC, If no why? Is your club active; if not when do you think you will be active? Who will be recording or reporting your service projects on MyLion president, secretary or club service chair?

Of the 31 clubs responding, 16 clubs have a club service chair; 15 do not. Reasons offered why clubs do not have a club service chair are as follows: clubs are too small, there is no interest to have a csc, one club said there is no useful purpose to have a csc, one club didn't see the point of having a csc, one club said their members lack computer skills and one club said they are not sure why they didn't have a csc. 26 clubs reported being active and 5 clubs are not active. 23 club's secretaries do the reporting, 3 clubs csc's does the reporting, 3 other clubs have both the secretary and csc do the reporting and one club's president does the reporting.

Some clubs including myself were having problems accessing MyLion. For me I typed in app.mylion.org and that took me into MyLion.

Chairperson Reports (Con't)

Hearing & Speech -

Update:

Back in April of this year as Hearing and Speech Director I felt I should reach out to all of my fellow Lion's. With Covid-19 putting a stop to everything in our worlds I want them to know that I was still think of them in this time of emotional difficulties. Keep in mind those who are without hearing and are home alone face even more loneliness as they

are most often without any form of communication at all. If you know of someone with hearing impairments who are unable to listen to the radio and who have limited access to the outside world we need to be creative in finding ways to support them even more today. Physical distancing is hard on all of us at the best of times.

I would hope that we are still encourage people to donate their used hearing aids. There have been community members who have been reaching out to me asking where they can drop off these aids off. I have been advising them to drop them off at their local lion's clubs and if they tell me the area they live I provide them with the closest lion's club. I have provided your public telephone number as well, as we know there are no lion's currently at the clubs and they can leave a message for your return.

It has been a challenging time for Dalhousie but they are still running, although at reduced capacity right now. They have continued to "see" patients who needed help with their hearing aids on a case by case basis. They have not provided hearing aids to new patients and will likely not do that until end of September there at the school. However, most of the people on our waiting list are from outside HRM and were going to be fitted with hearing aids by audiologists at the Nova Scotia Hearing and Speech Centres. They are waiting to hear when these audiologists are ready to see patience, hopefully sometime soon if they have not already started. There is one private practice audiologist in HRM who helps our program and who has started to re-open for new patients. He will be providing hearing aids to someone on our wait list in a week or two.

There has been a change at Dalhousie as all buildings are still locked down. Dalhousie Clinic phone number has changed it is now 902-494-2978, where people can leave a message. Messages are checked regularly on this phone.

AUDITOR'S REPORT

To the Members of the Lions Clubs International District N2

We have audited the accompanying financial statements of the Lions Club International District N2, which comprises the statement of financial position as at June 30, 2020 and the statements of income, members equity and statement of cash flows for the year then ended and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion in the effectiveness of the entity's internal control.

An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

Basis for Qualified Opinion

In common with many non-profit organizations, the Lions Clubs International District N2 derives revenue from fundraising, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, our verification of these revenues was limited to the amounts recorded in the records of the organization and we were not able to determine whether any adjustments might be necessary to fundraising, excess (deficiency) of revenue over expenses, current assets and net assets.

Qualified Opinion

In our opinion, except for the effects, if any, of the matter in the Basis for Qualified Opinion paragraph, the financial statements present fairly, in all material respects, the financial position of the **Lions Clubs International District N2** as at June 30, 2020, and its financial performance and cash flows for the year then ended in accordance with Canadian generally accepted accounting principles.
